## From the Trustees by Dave Osborn, Chairman

Members all,  
It has been a very difficult year financially at the Elks. With the debt of \$294,000.00 and the loss of revenue on the golf course due to weather, we have had to make very tough decisions to remain solvent. Needless to say revenues so far for the year are down over \$52,000.00 which means we are not able to meet all our obligations. If cuts were not put in place, foreclosure would be imminent.

The Trustees decided at that point we could no longer pay the golf course manager's salary and Shane was placed on lay off status. Our biggest concern was he would quit, however Shane has assured us he will return in the spring. As you remember we laid off club house hourly employees last year. This year when the club manager resigned we made the decision to operate without a manager until February of 2012 to save money.

Had we not made that decision we would have been forced to also lay off a new club manager. Our loan comes due January 8th 2012 and I have been working with Wells Fargo to secure another five year loan.

Support for the Stag/Staggett's is increasing. The numbers of members and guests in attendance has grown each time. Please keep up your interest, and bring a guest! They just might become a member.

The Nebraska Elks Association will be holding the Mid-Winter State Elks Meetings in Cozad on Saturday, January 7th. There will be a State Advisory Committee Meeting, followed by the State Trustee Meeting.

For 2012, LODGE DUES WILL NOT INCREASE! Lodge dues notices will be sent in Mid-January. Regular dues remain \$89. Life Member dues are still \$41.

Seventeen dollars of each member's dues is sent to Grand Lodge and the State Association for their operating expenses. The breakdown is as follows: \$3 goes to insurance, \$11 to Grand Lodge for operations and the magazine, and \$3 to the Nebraska Elks for operations.

While Elks dues remain the same, golf course membership dues will increase by 3.5%. Remember though, if golf dues are paid in full prior to April 1, 2012, the rate will be the same as 2011 (no increase). There will be a flyer with your Lodge dues notice explaining all of the options available.
